### Follow these steps to earn your rebate:

1. Verify that you qualify for Denver Water rebates. **See page 2 for complete eligibility rules.**
2. Purchase a qualifying model (see page 2) between Jan. 1 and Dec. 31, 2011. **Purchaser must be the one who applies for the rebate.**
3. Attach the entire receipt, which must include the date, brand and model number, to the application. Keep a complete copy for your records.
4. Submit a completed application, completed affidavit, copy of your identification and entire sales receipt to your water provider **within 90 days of purchase date. NO EXCEPTIONS.**

- High-efficiency toilet** (\$75 rebate, limit 3 per residence)

\*Account numbers beginning with 03 do not qualify.

- Rebates apply to qualifying items purchased between Jan. 1 and Dec. 31, 2011. No exceptions.
- The rebate applicant must be the purchaser of the fixture.
- All application forms must be accompanied by a valid sales receipt. A valid receipt shows purchaser name, installation address, date purchased, manufacturer name/make, model number and the price for each item. The valid receipt must indicate the item is paid-in-full.
- Online purchases must show the manufacturer make and model of the appliance or fixture. Purchases must show a "paid" status.
- Application forms without complete information or a valid receipt will be returned to the applicant.
- If a property has received a rebate for any of following since Jan. 1, 2002, the resident is not eligible to receive a rebate for the same item for 10 years:
  - 3 toilets
  - 1 weather-based smart controller
  - 1 wireless rain sensor
  - 1 clothes washer
  - 1 rebate for rotary nozzles

EXAMPLE: A customer who received a clothes washer rebate in 2006 is not eligible to receive another clothes washer rebate until 2016.
- Send rebate applications to your water provider who sends you your water bill. Your water provider will forward eligible applications to Denver Water for processing.
- If you live in an apartment or condominium, contact the management office and obtain your water account number.
- All applications must be accompanied by proof of lawful presence (affidavit) in the United States.
- All rebate applications must be submitted within 90 days of the purchase date. No exceptions.
- Only new fixtures or appliances qualify. Toilets and clothes washers that are used, leased, refurbished, rented, received from warranty or insurance claims, exchanged or won as a prize do not qualify for this rebate.
- Customers applying for a rebate must agree to allow Denver Water employees to access their properties in order to verify installation of devices eligible for rebates.
- Failure to cash a rebate check within 90 days of issuance shall void the rebate and shall relieve Denver Water of any obligation to pay the rebate. Rebate checks cannot be reissued.
- Make a copy of the entire application, receipt and affidavit, and keep the copy for your personal records.

#### Clothes washers (\$100 rebate, limit 1 per residence)

- Only models listed at [www.denverwater.org/conservation/rebates](http://www.denverwater.org/conservation/rebates) are eligible.
- Limit 1 clothes washer rebate per residence.

**NOTE:** The qualifying model list for the high-efficiency clothes washers is updated on a regular basis. The washer must be on a qualifying model list from 2011 and purchased within the last six months of the current list. Models on the list prior to 2011 that are not on the current list are not eligible for rebate.

#### High-efficiency toilets (\$75 rebate, limit 3 per residence)

- Only WaterSense-labeled toilets that use 1.28 gallons per flush or less listed on [www.epa.gov/WaterSense/product\\_search.html](http://www.epa.gov/WaterSense/product_search.html) are eligible.
- Limit 3 toilet rebates per residence.
- Low-flow toilets (1.6 gallons per flush) do not qualify for rebate.

**NOTE:** The qualifying model list for the high-efficiency toilet is updated on a regular basis. The toilet must be on a qualifying model list from 2011 and purchased within the last six months of the current list. Models on the list prior to 2011 that are not on the current list are not eligible for rebate.

#### Wireless rain sensors (\$50 rebate)

- Wireless rain sensor models that connect to an automatic, in-ground irrigation system are eligible for the rebate.
- Limit 1 rain sensor rebate per residence.

#### Rotary nozzles (\$5 rebate, minimum purchase is four)

- Eligible models include Hunter MP, Rain Bird and Toro Precision rotary nozzles. See qualifying model list for full details.
- One-time rebate per property.

#### Weather-based smart controllers (\$100 rebate)


- See qualifying model list at [denverwater.org/conservation/rebate](http://denverwater.org/conservation/rebate).
- Limit 1 weather-based smart controller rebate per residence.
- Some smart controllers operate based on historical information, while others operate based on current weather data transmitted each day from local weather stations during the irrigation season. Prices vary depending on the model, brand and vendor.
- Equipment cost and labor must be separated on receipt.

# Denver Water Rebate Affidavit

**State law requires you to prove lawful presence in the United States in order to receive the benefit of the rebate.**

**At the time this form was printed, forms of identification acceptable to the Colorado Department of Revenue include:**

- a valid, current Colorado driver’s license;
- a valid, current Colorado identification card;
- a valid, current driver’s license or identification card with applicant’s photograph issued by one of the following; Alabama, Arizona, Arkansas, California, Connecticut, Delaware, District of Columbia, Florida, Georgia, Idaho, Indiana, Iowa, Kansas, Kentucky, Louisiana, Maine, Minnesota, Mississippi, Missouri, Montana, Nevada, New Hampshire, New Jersey, New York, North Dakota, Ohio, Oklahoma, Pennsylvania, Rhode Island, South Carolina, South Dakota, Virginia, West Virginia, and Wyoming;
- United States Passport (except “limited” – issued for 5 years or less);
- a United States military card;
- a United States military dependent’s identification card;
- a United States Coast Guard Merchant Mariner card;
- a Native American tribal document;
- a naturalization or citizenship certificate;
- an I-94 immigration form with refugee or asylum status; or
- an unexpired resident alien card, permanent resident card, temporary resident card, or employment authorization card;
- any other form authorized by the Colorado Department of Revenue.



Please mail a photocopy of your identification (in one of the forms listed above) and your signed affidavit along with the other rebate paperwork. We assure you that this information will remain confidential. You may remove/darken all sensitive information such as driver’s license numbers or social security numbers from the copy of your ID that you submit to Denver Water. Expiration date must be visible.

## **AFFIDAVIT**

I, \_\_\_\_\_ (print name legibly), swear or affirm under penalty of perjury under the laws of the State of Colorado that (check only one):

- I am a United States citizen, or
- I am not a United States citizen, but I am a Permanent Resident of the United States, or
- I am not a United States citizen, but I am lawfully present in the United States pursuant to Federal law.

I understand that this sworn statement is required by law because I have applied for a public benefit. I understand that state law requires me to provide proof that I am lawfully present in the United States prior to receipt of this public benefit. I further acknowledge that making a false, fictitious, or fraudulent statement or representation in this sworn affidavit is punishable under the criminal laws of Colorado as perjury in the second degree under Colorado Revised Statute 18-8-503 and it shall constitute a separate criminal offense each time a public benefit is fraudulently received.
